

Terms and conditions of "1000 Promotional Points For Free"

§1 General provisions

- 1. The Operator of the "1000 Promotional Points For Free" is Currency One SA, the operator of InternetowyKantor.pl, NIP: 7831684097 / REGON: 301920555, District Court Poznań Nowe Miasto and Wilda, VIII Commercial Division of the National Court Register under the KRS number 0000402723 (Operator), enabling online currency exchange Website through the website at https://internetowykantor.pl (Website).
- 2. The Promotion Participant may be a natural person who is at least 18 years old and has full legal capacity, a legal person or an organisational unit without legal personality, but which may acquire rights and incur obligations on their own behalf, having a Bank Account, and who has registered on the Website.
- 3. The Operator declares that the Promotion is not a game of chance, lottery, raffle, parimutuel betting, promotional lottery, gambling whose result depends on lucky dip, or any other form of activity regulated by the provisions of the Act of 19 November 2009 on gambling (i.e. Polish Journal of Laws 2016, item 471, as amended).

§2 Scope of the promotion

- 1. The Promotion starts on 26.01.2024 at 00:01 (commencement date of the Promotion), and ends on 31.07.2025 at 23:59 (end date of the Promotion).
- 2. Participants in the Promotion may be persons who have fulfilled the following conditions listed below:
 - a) registered a User account on the Website during the Promotion period



- b) not been Users of the Website until the date of commencement of the Promotion, i.e. not had an account on the Website as a natural person, legal entity or organisational unit without legal personality.
- c) registered a User account on the Website via a registration form on one of the dedicated websites during the days of the Promotion:

- d) from the date of commencement of the Promotion, placed an order to exchange funds of ANY one-off value in any currency that the Website allows to be exchanged.
- 3. The "1000 Promotional Points" Participant may receive: 1000 promotional points for the purpose of exchanging foreign currency at an average market rate for the first registration of a new customer on InternetowyKantor.pl. 1 point refers to an opportunity to exchange foreign currency at an average rate, as per the table below:

Currency	How much will you exchange for 1 point
EUR, USD, CHF, GBP, AUD, BGN, CAD, NZD, RON, SGD, TRY	1 currency unit
CZK, DKK, HDK, HRK, MXN, NOK, RUB, SEK, ZAR	10 currency units

- 4. Exchange at the average rate means that it is the rate which is the arithmetic average between the operator's best available rates for the providers' purchase and sale of the currency in question. It also means that the difference between the purchase rate and the sell rate is equal to 0% (excluding the spread).
- 5. InternetowyKantor.pl provides the current average market rate in the User Account.

 Access to the User Account is granted upon successful registration.
- 6. Points awarded as part of the Promotion are valid for 3 months from the time of award.



- 7. Points will be automatically credited to your User Account account within one day of registration.
- 8. The Promotion does not combine with other promotional campaigns run by InternetowyKantor.pl.

§3 Rights and obligations of Participants

It is obligation of the Participant in the Promotion to abide by the provisions of these
Terms and Conditions under pain of exclusion from the Promotion in the event of
violating the provisions of the Terms and Conditions or other general norms, such as
conduct that is inconsistent with the applicable law, norms of social coexistence and
morality, socially unacceptable conduct and breaching the rules of etiquette.

§4 Rights and obligations of the Operator

- 1. The Operator reserves the right to exclude Participants from the Promotion, and in extreme cases to block participation in the Promotion of those Participants who breach the provisions of these Terms and Conditions.
- 2. In the event of force majeure or any other event beyond the Operator's control, the Operator reserves the right to extend, shorten, suspend, discontinue or cancel the Promotion. In such a case, the Operator will inform the Participants of the reasons for the changes and propose another form of promotion which will not worsen the existing conditions of participation, and in particular will not offer a prize of lesser value or of lower quality than the prize originally promised.
- 3. The Operator is not liable for:
 - a) potential technical problems, in particular related to operations of internet
 Website providers, which could affect fulfilment of the conditions of participation in the Promotion,



- internet connections, in particular for interruptions, suspensions or distortions
 of such connections which may result in a loss or destruction of electronically
 transmitted content,
- c) any problems arising from the operation of the banking websites, damage that may occur to Participants' computer systems in connection with interactions with the banking websites

§5. Personal data

- The administrator of the processed personal data is Currency One SA (NIP: 7831684097, REGON: 301920555, District Court Poznań Nowe Miasto and Wilda in Poznań, VIII Economic Department of the National Court Register under KRS number 0000402723), ul. Szyperska 14, 61-754 Poznań.
- 2. The scope of data processed under the promotion is equal to the scope of data processed under the standard terms and conditions of the Website.
- 3. The personal data as part of the Promotion will be processed in connection with the User's participation in the Promotion and the conduct of an eventual complaint process.
- 4. Processing of personal data is carried out in accordance with the law, in particular with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation). §6 Complaint procedure

1. Each Participant has the right to lodge a complaint related to non-compliance of the Promotion with these Terms and Conditions.

- 3. Complaints sent by e-mail to: biuro@internetowykantor.pl and in writing to the Operator's registered office address should be submitted with the annotation "1000 Promotional Points."
- 4. In the event that a complaint is rejected, the participant may bring an action before the competent court of law.
- 5. A participant who is a Consumer may use the out-of-court procedure for handling complaints and pursuing claims before The Permanent Consumer Arbitration Court at the competent Provincial Inspectorate of Trade Inspection.
